# DESCRIPTION

Coated in zinc to help prevent rusting, the CR 200 Wedge Anchor can be used as a post-installed anchor wherever fixtures need safely secured into concrete. The slight winged expansion wedges into the concrete base, creating a solid anchor for any fixture.

#### INSTALLATION

- Drill a 1/2" diameter hole perpendicular to the surface. The hole depth should take the fixture thickness into account and ensure 2-1/4" of minimum engagement.
- 2. Thoroughly clean the drilled hole with compressed air.
- 3. Position fixture in-line with the hole. Removing the nut and washer if necessary.
- Tighten the nut of the anchor using a torque wrench until the wedge engages in the hole. Typical installation can vary between 40-60 ft-lbs.
