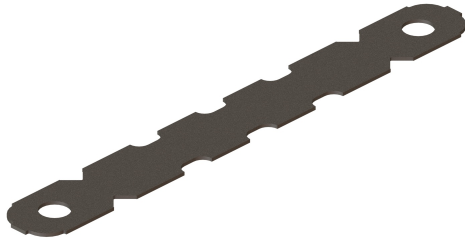


## TECHNICAL DATA SHEET
