### **DESCRIPTION**

Casica Blacktop Repair is an acrylic latex caulk designed for a flexible and durable seal when filling cracks in blacktop surfaces. The product is black in color and features a sanded texture to blend naturally with blacktop/asphalt surfaces.

#### USE

Repairing and sealing cracks from 1/8" (3.2mm) to 3/8" (9.5mm) in blacktop surfaces such as driveways.

#### **FEATURES**

- No mixing ready to use right from the tube using a standard caulk gun
- Durable and flexible
- Convenient for small repairs
- Cleans up with water

### **PROPERTIES**

Initial Set Time: 30 minutes Final Set Time: 60 minutes

### VOC

Casica Blacktop Repair has a VOC of less than 50 g/L. Compliant with all Canadian and U.S. VOC regulations including Federal EPA, OTC, LADCO, SCAQMD & CARB.

10.1 fl oz (300 mL) will fill cracks approximately 3/8 in. (9.5 mm) x 3/8 in. (9.5 mm) by 10' (3 m) long

## **STORAGE**

For best results all materials should be stored between 50°F (10°C) and 90°F (32°C) 24 hours prior to installation. Do not allow to freeze. Shelf life for unopened containers is 12 months.

### **Surface Preparation:**

Proper surface preparation is crucial to achieving a successful application.

- 1. Chisel out loose blacktop.
- 2. Clean all surfaces before application.
- 3. Cleaned surfaces may be moist.
- 4. Backfill deep cracks with sand or foam backer rod to within 3/8 in. (9.5 mm)
- of the surface.
- 5. Very small cracks should be slightly widened to permit penetration of caulk.

### Placement:

1. Cut the tube nozzle tip to the approximate width of bead desired and

puncture seal at the inside base of tip. Squeeze caulk into the crack using a

standard caulking gun.

Smooth and trim off excess caulk with a moist putty knife or jointing tool

while caulk is very fresh also assuring joints or cracks are filled full.

Crack surfaces to be caulked, and caulking material must be above 50°F

(10°C) and must remain so for 48 - 72 hours after application with no rain in

the forecast for proper curing.

4. Temperature and humidity will affect curing time.

### CURING

Allow to air-cure for 48 - 72 hours prior to traffic

### **CLEAN UP**

Cleans up with water prior to drying.

### LIMITATIONS

#### FOR PROFESSIONAL USE ONLY

Air, mix and substrate temperatures should be between 50°F (10°C) and 90°F

(32°C) and no rain in the forecast within 24 hours of application.

- Colder temperatures or higher humidity conditions will slow set times
- Protect from freezing for 48 hours after application.
