This rate is significantly better than the average rate of 4.9 for fabricated metal product manufacturing and the average rate of 6.1 for metal forging and stamping manufacturing.

The new initiatives, contributing to these safety advancements include:

- A comprehensive Root Cause Corrective Action program
- Case management conducted by senior-level management
- An Executive Safety Alert System
- Utilization of Environment Health & Safety (EHS) compliance software
- Ongoing, comprehensive safety training
