 3. All grades of Top-Cast are compliant with all Canadian and U.S. VOC regulations for sealers including Federal EPA, OTC, LADCO, SCAQMD and CARB
 4. SCAQMD requires products to conform to lowest VOC for advertised use, so bond breakers fall under cures
- * Aerosol can products are also measured by MIR (maximum incremental activity) or VOC % by weight. J62 has an MIR of 1.22 and a V.O.C. 51.1% by weight
 - ** Only seven Utah counties are under these regulations: Box Elder, Cache, Davis, Salt Lake, Tooele, Utah, and Weber
 - *** CO Reg 21 states product must be less than 50% VOCs by weight

- SCAQMD:** In the State of California, all of Orange County, urban portions of Los Angeles, Riverside and San Bernardino Counties
- CARB:** State of California, other than those under the SCAQMD regulations
- OTC:** States of CT, DE, MA, ME, NH, NJ, NY, PA, RI, VT, No. VA, District of Columbia
- LADCO:** States of IL, IN, MI, OH, WI
- EPA:** All States not governed by the more restrictive aforementioned regulatory agencies
- Maryland:** Maryland VOC standards changed January 1, 2017
- Utah:** Only the following counties are under these regulations: Box Elder, Cache, Davis, Salt Lake, Tooele, Utah, and Weber
- Col Reg 21:** Colorado VOC standards changed May 1, 2020
