







DESCRIPTION

B2 coil ties are strong, versatile resistance welded ties designed to take the abuse encountered in medium and heavy concrete construction

APPLICATION

The coil ties can be used as a combination tie and form spreader when it is not necessary to keep the ends of the tie back from the face of the concrete.



FEATURES

- It can be used with or without cones
- Can be combined with coil rod to form an adjustable tie
- Available in 1/2", 3/4", 1", 1 1/4" and 1-1/2" diameters in plain or electro galvanized finish

- To determine the required coil tie length, subtract two times the desired or specified setback from the wall thickness
- Safe working load provides a factor of safety of approximately 2 to 1
- Can be used with B4 Water Resistant Washer to break the continuity of the tie to help eliminate water seepage long the tie.
