DESCRIPTION

Both the T7S and T7ST are used with standard coil threaded inserts to provide void for the B14 Coil Bolts.

The Dayton Superior T7S Slotted Setting Stud has a slot to facilitate installation and removal.


The T7ST stud has a slot and is drilled 1" deep and tapped with 1/4"-20 threads to allow the stud to be used as an insert setting plug.

APPLICATION

Threads and slots should be coated with non-staining lubricant to prevent bonding.

To ease removal when ready to lift, loosen studs within 2 to 12 hours after concrete placement.





FEATURES

- Made from continuous threaded steel rod.
- The top is cut off to form a square so screed can easily pass over.
- Standard steel sizes are 1/2", 3/4", 1", 1-1/4" and 1-1/2" diameter x 4" long. Other lengths available on request.
