

## DESCRIPTION


A22 Spreader Cleats are manufactured from high strength steel.

### APPLICATION


A22 Spreader Cleats are used to form footers or grade beams up to 32" high.







A22 Spreader Cleat - Stamped Metal



### **FEATURES**

- On panels up to 24" high the cleats are spaced at 32" maximum center to center spacing.
- For panels over 24" and up to 32", the cleats should be spaced at 24" maximum center to center spacing.
- Two versions of the spreader cleat are available. The stamped metal cleat is available for 6" and 8" wall thicknesses with 3/4" or 1-1/8" lumber ends. The other spreader cleat version utilizes two lumber ends attached wtih a wire strut. This version is available for wall thicknesses over 5" with 3/4", 1-1/8", 1-5/8" and 2-1/4" lumber ends.

Safe Working Load is 750 lbs. which provides a factor of safety of approximately 2 to 1.
