
# **TECHNICAL DATA SHEET**

# DESCRIPTION

The A6 Spandrel Point Tie is similar to theA3 Snap Tie with the exception of the end configuration.

# APPLICATION

Dayton Superior A6 Spandrel Point Tie is available for tying light outside spandrel beam forms.



### **FEATURES**

- One end is fabricated with a standard end with any style plastic cone or spreader washer. The opposite end is bent 90° with a chisel point that is driven into the deck formwork.
- Breakback dimension is the same as standard snap ties.
- Dayton Superior recommends placing a 1-1/4" fence staple over the tie within 1" of the bend.
- Safe Working Load is 250 lbs. which provides a factor of safety of approximately 2 to 1. Safe Working Load is controlled by wood spreader.
