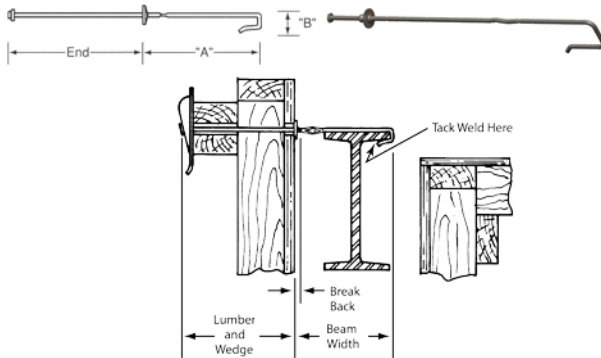


TECHNICAL DATA SHEET**DESCRIPTION**

The A7 Spandrel Hook Tie is similar to the A3 tie with the exception of the end configuration, which is hooked.

APPLICATION

Dayton Superior A7 Spandrel Hook Tie is available for securing light outside spandrel beam forms to structural steel beams.

**FEATURES**

- The hook end of the A7 tie fits over the beam flange and is tack welded on the underside of the beam flange.
- The A7 tie is available with any type of spreader washer or plastic cones.
- Safe Working Load is 250 lbs. which provides a factor of safety of approximately 2 to 1. Safe Working Load is limited to hooked end of tie.
