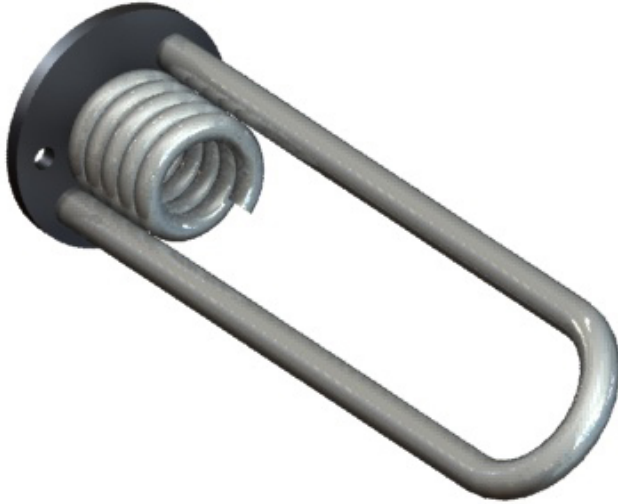

The B16W Straight Coil Loop Insert with Washer is highly efficient for lifting and handling precast concrete elements.

- Made of a single U shaped looped wire strut that is welded to a helix coil with a nailing washer face

TECHNICAL DATA
