DESCRIPTION

The C41 Coil Rod Hanger is a U shaped wire with (2) 90° bends which are threaded on both ends for 1/2" coil nuts. There is a 1" break back to the horizontal leg to the fixed hanger

APPLICATION

Coil Rod Hanger is placed over steel beam or concrete girder with capability to adjust grade after formwork is installed. When used on steel beams or girders, legs formed at 90° to the top flange are recommended. For concrete girders of box beams, legs formed at 15° to vertical are suggested.
