The Cure & Seal 30% J23WB formula is low odor and contains VOC < 100 g/L, making it VOC compliant in all areas. Cure & Seal 30% J23WB cures, seals and dustproofs freshly finished concrete surfaces.

USE

Cure & Seal 30% J23WB is designed to be used on freshly finished concrete and surpasses the requirements of ASTM C-309 and C-1315. Cure & Seal 30% J23WB can be used on both interior and exterior concrete surfaces.

Texture and absorption rate of the concrete will influence coverage rate.

STORAGE

The Cure & Seal 30% J23WB should be stored in tightly sealed original factory containers. Store in a horizontal position to prevent moisture accumulation on the drum head. Do not allow to freeze. Shelf life of properly stored, unopened containers is 18 months.

Mixing

Stir thoroughly prior to use. Do not thin or dilute.

Placement:

Apply Cure & Seal 30% J23WB immediately after all surface water has disappeared and surface cannot be marred. Application of Cure & Seal 30% J23WB too early or too late can affect the overall curing performance. Use low pressure spray, roller or brush. Apply uniformly without puddles. Multiple thin coats are preferable over heavy coats. For improved application consistency and reduction in labor, use the Dayton Spray-Pro (Item # 309233 or 309232) power spray system. Application of a second coat, after the first coat has dried will provide a longer lasting, higher gloss film with improved water retention properties.

CLEAN UP

Clean tools and equipment with clean water while product is still wet. Dried material may be removed with Green Bean Clean.

LIMITATIONS

FOR PROFESSIONAL USE ONLY

This product should not be used at temperatures below 40°F (4°C). Do not apply concrete or mortar toppings over sealed surfaces. Avoid spraying Cure & Seal 30% J23WB into joint prior to installation of sealant. May show rubber tire marks. Do not use high speed mixing equipment. Remove Cure & Seal 30% J23WB with Citrus Cleaner J48 or Green Bean Clean® before applying resinous (epoxy, polyester, urethanes, etc.) coatings. When moisture-sensitive flooring is to be applied to the concrete treated with this product first refer to ACI 302.2R
