
DESCRIPTION

D27 Lag Bolt is designed to provide a temporary means of attaching formwork to wood timbers.

APPLICATION

Typical application is one-sided blind forming against steel soldier piles with wood lagging.





FEATURES

- The Safe Working Load (SWL) of the lag bolt is dependent on a range of variables with respect to the lumber/timber used. A design professional should determine the capacity for each specific application.
- Lag bolts should have full thread engagement to carry the required load.
- Fast installation
- Reduces need for external bracing
- Speeds up concrete pours
- Simplifies foundation wall forming

INSTALLATION

- 1. Drill 9/16" pilot hole in lagging
- Screw bolt, tapped with 1/2" diameter thread, into wood lagging
- Install 1/2" NC threaded rod and she-bolt assembly
