
DESCRIPTION


The Dayton Superior F54TRD Third Rail Anchor is used to secure the third rail on commuter rail systems. The insert is cast in the concrete tie and used to mount the holding fixture for the third rail.

The F54TRD allows for quick fastening of the fixture with the 3/4" - 10 UNC bolt.

APPLICATION

The F54TRD is installed in concrete rail ties and used for attaching the third rail holding system.
