INSTALLATION

- Grasp the recess plug firmly across the top diameter of the plug
- Application of pressure by the thumb and fingers on the outer edge of the plug will cause the plug to open up to allow insertion of the anchor
- 3. Swift Lift recess plugs provide two holes in the top surface that are used in the removal process insert two screw drivers or steel rods into the holes and simply lever the two across the plug for easy removal
