
TECHNICAL DATA SHEET

DESCRIPTION

The 275P patch cap is molded from PC/ABS engineered polymer.

APPLICATION

T275P patch cap is a durable plastic patch designed to quickly cover setting plug recesses of T275 or T110 tilt-up lifting inserts.



FEATURES

- The patch is supplied in a concrete gray color with a matte finish that allows subsequent painting, if desired.
- Fast, one-piece "push-on" installation
- Weather and chemical resistant
- Oval shape: 4.3"x9"

INSTALLATION

- 1. Start the patch grippers on the top edge of the anchor
- 2. Push the patch onto the anchor and flush with the concrete

NOTE: The T275P patch cap will not prevent corrosion or rusting of an embedded anchor that is subject to wet conditions. Spraying the anchor with a corrosion resistant compound and applying a bead of silicone around the underside of the patch will help prevent moisture penetration.
