## **DESCRIPTION**

The Dayton Superior T63 Steel Strongbacks are an assembly of steel channels used for concrete Tilt-Up panels. These assemblies are comprised of back-to-back steel channels welded together via plate steel end-caps. The welded end-cap allows for a bolted butt-splice connection of multiple strongbacks. The 12" strongbacks come in a variety of lengths.

- Available in lengths of 10', 15', or 20'.
- The strongbacks can be bolted together using 1"x3.5" A325 Bolts. This allows for additional length configurations to be created.
- Built using C12 X 20.7 Steel Channels.
- Channel opening of 3" to allow for numerous hardware options and field tolerance.
- Assembled weight of 41.4 lbs per linear foot.


