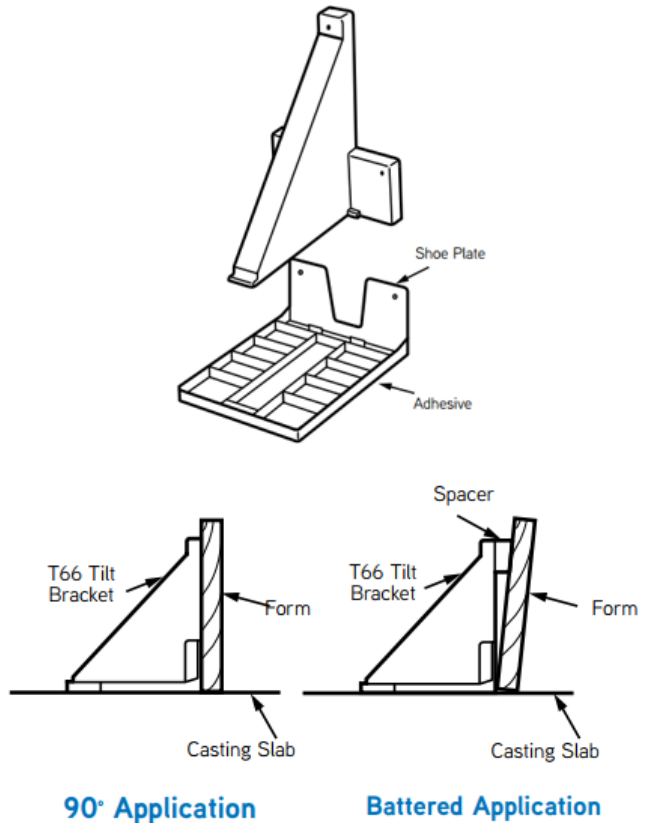
- The bracket snaps into the shoe plate that is held firmly to the casting slab by the adhesive base
